## 1. General regulation

1.1. This Regulation (hereinafter referred to as the Regulation) regulates the procedure for organizing and holding the International Olympiad of Students of Educational institutions of secondary vocational Education in the specialty 38.02.07 Banking (hereinafter referred to as the Olympiad)

1.2. The Olympiad is held within the framework of the Congress of Economists and Financiers of the Eurasian Economic Youth Forum (hereinafter referred to as the EEYF). EEYF website's Internet address [www.eurasia-forum.ru](http://www.eurasia-forum.ru)

1.3. The organizer of the Olympiad:

FSBEIBO «Ural State University of Economics» (USUE), USUE College.

1.4. The purpose of the Olympiad is to develop and improve banking education, improve the level and quality of training of students of professional educational organizations in the specialty 38.02.07 Banking in the interests of personal development and its creative abilities, adapt their theoretical and practical knowledge to the specific conditions of functioning of credit institutions.

1.5. Main objectives of the Olympiad:

- determination of the level of training of banking specialists;
- student's understanding of the essence and social significance of their future profession, showing a sustained interest in it;
- ability to make decisions in standard and non-standard situations and take responsibility for them;
- develop skills in self-preparation, teamwork and techniques and presentations;
- identifying the most gifted and talented students and providing assistance in their professional orientation and continuing their economic education;
- promotion of students ' professional self-determination and adaptation of their theoretical knowledge to the specific conditions of functioning of credit institutions;
- increasing the prestige of secondary vocational education institutions and Banking specialties;
- development of cooperation with educational organizations that implement educational programs in banking;
- strengthening cooperation with social partners.

## 2. Conditions for participation in the Olympiad, registration of participants


2.1. Students of the final year of secondary vocational education programs in the specialty 38.02.07 Banking are invited to participate in the Olympiad.

2.2. Participation in the Olympiad is individual.

2.3. Applications for participation in the Olympiad are accepted through the registration system of the EEYF website [www.eurasia-forum.ru](http://www.eurasia-forum.ru). (appendix 1).

2.4. Applications for participation in the Olympiad are submitted within the deadline specified on the Olympiad page of the EEYF website.

2.5. There is no registration fee for participation in the Olympiad. Expenses for accommodation of nonresident participants, food and transportation expenses for participation in the full-time stage of the Olympiad are paid by participants themselves, or by sending organizations.

### **3. The order and terms of the Olympiad**

3.1. The Olympiad is an annual event and is held within the framework and terms of the EEYF. Specific dates of the Olympiad, as well as its main stages, are set by the order of the rector of FSBEIBO «Ural State University of Economics».

3.2. The Olympiad is held in three stages.

3.2.1. The first stage is registration of participants and checking for compliance with the requirements for participants of the Olympiad (section 2 of these Regulations).

The first stage is held by the organizing committee Olympic Games within the time limits set by the Directorate of the Eurasian Economic Youth Forum and published on the SES website.

3.2.2. The second stage – (qualifying), is held remotely.

The e-mail address of the participant specified during registration on the EEYF website is sent to the address of the specialized website, login and password for completing tasks of the qualifying round of the Olympiad.

The participant logs in to this site using their username and password and performs the following tasks:

1) "Testing": the test task completion time is 60 minutes, the number of questions is 40, and the number of attempts to pass the test is -1.

Based on the results of the qualifying round, the 20 finalists with the highest number of points are determined. Lists of finalists are posted on the Olympiad page of the EEYF website.

3.2.3. The third stage – (final), is held in person at USUE.

The third stage includes:

1) "Testing": the task completion time is 40 minutes, the number of questions is 20, and the number of attempts to pass the test is 1.

2) "Creative task": a practical task on the topic "Promotion and sales of a banking product" in real time according to the terms of the task case.

The participant who has reached the final is sent a case study of tasks to the email address specified during registration, on the basis of which they must prepare and submit a presentation on the promotion and sale of a particular banking product for defense in the final. The finalist should analyze such main characteristics of the financial product as the type, target audience, risk-return, acquisition costs, advantages over similar products, methodology for using cash and settlement services for customers, etc.


According to the results of the final round, the winner and prize-winners of the Olympiad are determined.

### **4. Strands of the Olympic Final and criteria for evaluating works**

4.1. Competitive tasks of the Olympiad include the performance of professional tasks, the content of which corresponds to the Federal State Educational Standard of vocational Education in terms of state requirements for the minimum content and the level of training of graduates in the specialty 38.02.07 Banking.

4.2. All tasks provide for an assessment of the implementation of professional competencies within the framework of:

- General professional disciplines: op. Finance, money circulation and credit; op. Organization of accounting in banks;
- PM. 01 Conducting settlement operations;
- PM. 02 Implementation of credit operations;

- PM. 03 Performing work in one or several professions of workers, positions of employees (Bank Agent)

4.3. An expert commission of the Olympiad is created to conduct an expert assessment of works. All decisions of the expert commission are recorded and signed by the chairman, secretary and members of the expert commission (Appendix 2, 3). The Expert Commission has the right to appoint additional nominations in the Olympiad.

4.4. During the second (qualifying) stage, the Olympiad expert Committee checks the participants' works and determines 20 (twenty) finalists.

4.5. Lists of finalists are displayed on the Olympiad page and information letters about reaching the final are sent to the finalist participants. If the finalist is unable to take part in the final in person for any reason, by decision of the organizing committee of the Olympiad, he can be replaced by the participant who took the 21st place.

4.6. Criteria for evaluating works at the second (qualifying) stage:

1) "Testing": evaluates the correct answers to the test questions. For the correct answer to each question 1 point, the maximum number of points is 40.

4.7. Criteria for evaluating work during the third (final) stage:

1) "Testing": evaluates the correct answers to the test questions. For the correct answer to each question 1 point, the maximum number of points is 20.

2) "Creative task": the maximum number of points is 30.

The creative task in the final is evaluated according to the following criteria:

- work with various sources of information - maximum number of points – 5,
- relevance of the material - maximum number of points – 5,
- logic, clarity of presentation - maximum number of points – 5,
- availability of practical examples - maximum number of points – 5,
- ability to conduct polemics - maximum number of points – 5,
- validity of the formulated conclusions - the maximum number of points is 5.

## **5. Managing the Olympiad**

5.1. The Olympiad is managed by the EEYF Directorate and the Olympiad Organizing Committee.

5.2. To organize and conduct the Olympiad, an Organizing Committee is formed, approved by the order of the USUE Rector. The Organizing Committee consists of:

- Chairman of the EEYF Organizing Committee;
- Co-chairman of the EEYF Organizing Committee;

Members of the Organizing committee:


- scientific supervisor of the Olympiad;
- coordinates of the Olympiad'sp(s).
- Chairman and members of the Olympiad expert Commission;
- representatives of partner organizations of the Olympiad,
- Secretary of the Olympiad.

5.3. The Organizing Committee provides general management of the organization and conduct of the Olympiad.

5.3.1. Chairman of the Organizing Committee:

- approves the Regulations on the Olympiad, signs the order on the conduct of the Olympiad and the composition of the Organizing committee of the Olympiad, the order on the composition of the expert commission;

- provides general management of the organization and conduct of EEYF events, within the framework of which the Olympiad is held.

#### 5.3.2. Co-Chairman of the Organizing Committee:

- directly manages the organization and conduct of the EEYF, together with the academic supervisor of the Olympiad, forms the composition of the expert commission of the Olympiad.

#### 5.3.3. An expert commission is created to conduct an expert assessment of teams.

The Chairman of the Olympiad Expert Committee is the Director of the EEYF Congress, which hosts the Olympiad. The expert commission consists of highly qualified representatives of the scientific and business community; Russian and foreign experts in the field of finance from higher educational institutions of the Russian Federation, countries of Near and Far Abroad, academic science, audit companies; business practitioners.

More than half of the members of the expert commission must be representatives of third-party organizations.

#### 5.3.4. Academic Supervisor of the Olympiad:

- prepares the draft Regulations on the Competition and submits them to the rector for approval, prepares amendments and additions to it;

- Co-chairs the expert commission of the Olympiad;

- selects the composition of the Olympiad expert commission;

- develops and approves tasks for participants of the Olympiad from the chairman of the expert commission.

#### 5.3.5. Contest co-ordinate number(s):

- ensures the invitation of members of the Olympiad expert commission;

- organizes the distribution of informational letters to educational, research and scientific organizations of the Russian Federation and foreign countries;

- ensures the operation of a specialized website for conducting the qualifying round of the Olympiad;

- organizes the final and the work of the expert commission during the final of the Olympiad;

- organizes registration of diplomas and awarding of winners and prize-winners of the Olympiad;

- prepares a report on the conduct of the Olympiad.

5.4. Information about the supervisor, coordinator(s), as well as members of the expert commission of the Olympiad are published annually on the Olympiad page of the EEFM website.

## **6. Awarding of winners**

6.1. According to the results of the final round, the winner and prize-winners of the Olympiad are determined. The winner and prize-winners are awarded with Diplomas of I, II, III degrees and orders for 1,2, and 3 places, respectively.

All participants of the final round receive certificates of finalists of the Olympiad.

6.2. The participants who took 4th and 5th places, as well as the winners of additional nominations of the Olympiad (if there are any nominations) are awarded with diplomas, respectively, for the 4th and 5th place in the Olympiad, or for winning the nomination.
