1. General Provisions

1.1 This Regulation (hereinafter referred to as the Regulation) regulates the procedure for organizing and holding the International Competition for Young Scientists and Students' Articles "Problems of Economic Theory and Behavioral Economics" (hereinafter referred to as the Competition).

1.2 The competition is held within the framework of the Congress of Economists and Financiers of the Eurasian Economic Youth Forum (hereinafter referred to as EEYF). Internet address of the EEYF website www.eurasia-forum.ru.

1.3 Contest organizer:

"Ural State University of Economics" (USUE), Department of Economic Theory and Corporate Governance.

1.4 Co-organizers of the Competition:

Universities-organizers of foreign and regional EEFM sites that have chosen this competition for implementation on their sites. The list of foreign and regional sites that have chosen this Competition is indicated on the Competition page of the Congress of Economists and Financiers of the EEFM website, as well as on the foreign/regional Sites of the EEFM website themselves

1.5 Partners of the competition:

- Institute of Economics of the Ural Branch of the Russian Academy of Sciences;
- Ural Branch of the Free Economic Society of Russia.

1.6 Purpose and objectives of the Competition:

1.6.1 The purpose of the competition "Problems of Economic Theory and Behavioral Economics" is to discuss by young scientists and students the mechanism for solving economic problems from the standpoint of various schools and areas of economic theory, in particular, from the standpoint of behavioral economics, analysis of the interaction of modern economic and psychological sciences.


1.6.2 Objectives of the Competition:

- attracting the attention of young people to the new requirements for specialists in the digital economy;
- analysis and generalization of various areas of practical use of the achievements of modern economic theory and behavioral theory;
- development of recommendations on the use of the provisions of modern economic theory and behavioral economics to analyze economic phenomena and evaluate the results of the functioning of various institutional structures.

2. Scientific directions of the Competition

The thematic directions of the Competition are determined annually in accordance with the theme (directions) EEFM and are published on the Contest page on the EEFM website (www.eurasia-forum.ru). Scientific articles for the 2023 Contest are sent in the following directions:

1. Evolution of coordination mechanisms in the modern economy. Contract theory and auction theory.
2. Creativity and innovation of consumers: the evolution of preferences: non-standard preferences, socially oriented preferences.
3. Non-standard decision-making in conditions of risk and uncertainty.
4. "Information cascades", the asymmetry of "information waves" and their impact on economic thinking, the capital of socially-oriented thinking.

5. The behavioral basis of interaction in a virtual environment, artificial intelligence and the possibilities of its application in the modern economy.

6. Problems of "paternalism" in the modern economy.

3. Terms of participation in the Contest

3.1. Students, graduate students, young scientists, educational organizations, academic institutions and other interested organizations in Russia and foreign countries under the age of 35 (hereinafter referred to as Participants) are invited to participate in the Competition.

Articles prepared by young scientists - candidates of sciences, are not accepted for the competition.

3.2. Scientific articles for the Competition can be sent only from individual authors.

3.3. One participant has the right to submit only one article to the Competition.

3.4. The authors themselves decide in which scientific direction the work will be presented.

3.5. Articles of participants that do not meet the requirements of clause 5 of these Regulations are not accepted for participation in the competition.

3.6. There is no registration fee for participation in the competition. Expenses for accommodation of non-resident participants, food and transportation costs for participation in the full-time stage of the competition are paid by the participants themselves, or by sending organizations.

4. Stages and terms of the Competition

4.1. The competition is an annual event and is held during the summer semester. The final dates for the Competition, as well as its main stages, are established by the order of the rector of the Ural State University of Economics.

4.2. The competition is held in three stages.

4.2.1. The first stage is the acceptance and registration of competitive scientific articles of the Competition; verification of work for compliance with the requirements for work.

The first stage is carried out by the Organizing Committee of the Competition, within the time limits set by the Directorate of the Eurasian Economic Youth Forum.

4.2.2. The second stage - (qualifying) examination of competitive scientific articles registered and admitted to the Competition based on the results of the first stage; determination of the finalists of the Competition.


Examination of competitive articles is carried out by the expert commission of the Competition. Lists of Participants who have passed to the final of the Contest are being formed. Lists of finalists are published on the Competition page of the EEYF website.

4.2.3. The third stage is the (final) defense of competitive scientific articles by the finalists; determination of winners and prize-winners of the Contest.

The third stage is held between the finalists of the Competition by public defense of competitive works at a special meeting in the presence of members of the expert commission of this Competition.

4.3. Based on the results of the Competition, a collection of articles by the finalists is published. The collection is published in the form of the corresponding chapter of the annual collection of materials of the EEYF no later than 3 months

after the competition. The EEYF collection of materials is posted in the RSCI, on the USUE website and on the EEYF website.

5. Requirements for the submitted documentation and rules for registration of competitive works (scientific articles)

5.1. Works are submitted to the Organizing Committee of the Competition in electronic form through a special registration form on the EEYF website www.eurasia-forum.ru.

5.2. To participate in the Competition, the following package of documents must be submitted:

- 1) the author's application for participation in the Competition (Appendix 1) - submitted by filling out the registration form of the participant on the EEYF website;
- 2) the text of the work (scientific article) is attached as a separate file to the participant's registration form;

5.3. The competitive work (scientific article) must meet the following requirements:

- 1) a scientific article must be submitted within the deadlines set by the rector of USUE and published on the EEYF website;
- 2) a scientific article must correspond to the problems of the Contest and its thematic areas, corresponding to paragraph 2 of these Regulations;
- 3) a scientific article must have a reference apparatus: references to sources from which quotes are used, digital data in the text, tables, graphs, diagrams, a list of references (at least 5 sources);
- 4) scientific article must be author's, the percentage of originality of the text must be at least 70%;

A scientific article must be formatted in accordance with the following requirements: file in *.doc or *.rtf format, titled by the author's surname, A4 format, Times New Roman font, font size - 14 pt, line spacing - one and a half. All margins are 20 mm. The text should be justified in width without hyphenation. Sheet orientation is portrait. Paragraph indent - 1.25.

All charts and tables must be inserted into the text. The list of references (bibliographic list) is drawn up in accordance with GOST R 7.0.100-2018. Footnotes to the text are given in square brackets, indicating the number of the source in the list of references.

The volume of the article is no more than 5 pages.


6. The procedure for holding the Competition and the criteria for evaluating works

6.1. At the first stage of the Competition, the Organizing Committee admits competitive works (scientific articles) for further expert evaluation according to the requirements specified in paragraph 5 of the Regulations.

6.2. During the second (qualifying) stage, the expert commission of the Contest conducts an examination of the competitive works (scientific articles) of the participants and determines 15 (fifteen) finalists of the Contest.

Criteria for evaluating competitive works at the second (qualifying) stage:

- 1) registration of work - up to 10 points;
- 2) relevance of the research topic - up to 15 points;
- 3) novelty and originality of the research – up to 15 points;
- 4) content of the study: scientific, technical and economic feasibility of the proposed solutions; logic, scientific style and literacy of presentation; the presence of applications, illustrations, graphic explanations of appropriate quality - up to 40 points;
- 5) practical significance of the research results, the possibility of testing and implementing the results obtained - 20 points.

Lists of finalists are posted on the Competition page. Information letters about reaching the finals are sent to the finalists.

If the finalist cannot personally take part in the final of the Competition, he is given the opportunity to publicly defend the competitive work remotely, in the form of a webinar. If the finalist cannot take part in the final of the Contest remotely, the participant who took 16th place according to the results of the second (qualifying) stage of the Contest is included in the list of finalists.

6.3. During the third (final) stage, the members of the expert commission fill out an expert list for each finalist of the Competition.

Criteria for evaluating participants during the full-time defense of the competitive work (scientific article) at the third (final) stage:

- 1) relevance of the research topic - up to 15 points;
- 2) novelty and originality of the research – up to 15 points;
- 3) the significance of the results of the study - up to 20 points;
- 4) presentation - up to 20 points;
- 5) defense (answers to experts' questions) - up to 30 points.

6.4. Priority in the form of additional points (up to 10 points) is given to competitive works completed in the areas of the Competition within the framework of the annual theme of the EEYF.

6.5. In the event that the winners and prize-winners of the Competition have the same (equal) number of points, the decision to determine the winners and prize-winners is made by the expert commission of the Competition.

7. Competition Management

7.1. The Competition is managed by the EEYF Directorate and the Organizing Committee of the Competition.

7.2. To organize and conduct the Competition, an organizing committee is formed, approved by the order of the rector of USUE. The organizing committee includes:

- Chairman of the EEYF Organizing Committee;
- co-chairman of the organizing committee of the EEYF;
- scientific supervisor of the Competition;
- coordinator(s) of the Competition;
- Chairman and members of the expert commission of the Contest;
- representatives of organizations – partners of the Contest;
- Contest secretary


7.3. The Organizing Committee carries out general management of the organization and conduct of the Competition.

7.3.1. Chairman of the Organizing Committee:

- approves the Regulations on the Contest, signs the order on holding the Contest and the composition of the Organizing Committee of the Contest, the order on the composition of the expert commission of the Contest;

- carries out general management of the organization and conduct of EEYF events, within the framework of which the Competition is held.

7.3.2. Organizing committee co-chair:

– carries out direct management of the organization and conduct of the EEYF, together with the Scientific Supervisor of the Competition, forms the composition of the expert commission of the Competition.

7.3.3. An expert commission of the Competition is created to conduct an expert assessment of the competitive works.

The chairman of the expert commission is the director of the EEYF Congress of Economists, within the framework of which the Competition is held. The expert commission includes highly qualified pedagogical and scientific workers, leading specialists from among the organizers of the EEYF, as well as invited experts. More than half of the members of the expert commission must be representatives of outside organizations.

The decisions of the expert commissions are recorded, the protocols are signed by the chairman, secretary and members of the expert commission (Appendix 3, 4).

7.3.4. Scientific Supervisor of the Competition:

- prepares the draft Regulations on the Competition, as well as changes and additions to it;
- is a co-chairman of the expert commission of the Contest;
- selects the composition of the expert commission of the Contest;

7.3.5. Contest Coordinator:

- ensures the invitation of members of the expert commission of the Contest;
- organizes the distribution of information letters to educational, research and scientific organizations of the Russian Federation and Eurasian countries;
- organizes the registration and verification of the compliance of the received competitive documents with the established requirements, sends the competitive works to the members of the expert commission for evaluation;
- organizes and controls the course of the Contest;
- organizes the final and the work of the expert commission during the third stage of the Competition;
- organizes the issuance of diplomas and the awarding of winners and prize-winners of the Competition;
- organizes the collection of competitive works (scientific articles) of the finalists of the Competition and their transfer to the USUE Publishing House for inclusion in the collection of materials of the EEYF;
- draws up a report on the Competition.


7.4. The composition of the organizing committee, the expert commission of the Competition is published annually on the Competition page of the EEYF website.

8. Awarding of winners

8.1. According to the results of full-time defense, the winner and prize-winners of the Competition, who took I, II, III places, are determined.

The winners and prize-winners of the Contest are awarded with Diplomas of I, II , III degree and orders and cash prizes in accordance with the minutes of the meeting of the expert commission of the Contest.

8.2. Participants who take IV and V places receive certificates for 4 and 5 places, respectively.
