#### 1. General provisions

- 1.1. This Regulation on the Scientific and Applied Competition "Financial Foresight" (hereinafter referred to as the Regulation) regulates the procedure for organizing and conducting the Scientific and Applied Competition "Financial Foresight" (hereinafter referred to as the Competition).
- 1.2. The competition is held within the framework of the Congress of Economists and Financiers of the Eurasian Economic Youth Forum (hereinafter referred to as the EEYF). EEYF website's Internet address www.eurasia-forum.ru
  - 1.3. Contest Organizer:

Ural State University of Economics (USUE), Institute of Economics and Finance, Regional Center for Financial Literacy.

1.4. Co-organizers of the Contest:

Universities-organizers of foreign and regional EEYF sites that have chosen this competition for implementation on their sites. The list of foreign and regional sites that have chosen this Competition is indicated on the Competition page of the Congress of Economists and Financiers of the EEYF website, as well as on the foreign/regional Sites of the EEYF website themselves

1.5. The aim of the course is to create a sustainable interest and motivation of young people in Russia and other countries to participate in activities aimed at improving the financial literacy of the population of their countries.

#### 2. Terms of participation in the Contest

- 2.1. Participants of the Competition are students, postgraduates, young specialists of educational organizations, academic institutes and other interested organizations of Russia and foreign countries under the age of 35 (hereinafter referred to as Participants).
- 2.2. There is no registration fee for participation in the contest. The cost of accommodation for nonresident participants, food and transportation costs for participation in the full-time stage of the competition are paid by participants themselves, or by sending organizations.

#### 3. Procedure and terms of the Contest

- 3.1. The competition is an annual event and is held during the summer semester. The final terms of the Competition, as well as its main stages, are established by the order of the Rector of the Ural State University of Economics.
  - 3.2. The competition is held in three stages.
  - 3.2.1. THE FIRST STAGE (qualifying):
- acceptance, registration and verification of the submitted tender documentation for compliance with the requirements of Section 5 of this Regulation.
- examination of participants' projects submitted during registration to improve financial literacy of a certain category of citizens. Determination of the finalists of the Competition.

The examination of competitive works (selection projects) is carried out by the expert commission of the Competition / expert commissions of the Competition sites. 20-25 people are brought to the final, whose competitive works have scored the highest number of points according to the results of the

examination. The lists of the finalists of the Competition are published on the Competition page of the EEYF website.

The first stage is held by the organizing committee of the Competition within the time limits set by the Directorate of the Eurasian Economic Youth Forum and published on the Competition page of the EEYF website.

- 3.2.1. THE SECOND STAGE (installation STAGE) is held one day before the final of the Contest:
- -a master class is organized for the finalists of the Competition, where they are given instructions on the principles and features of developing projects on financial literacy, the existing practice of their application among various categories of the population;
- -project groups (teams) of up to 5 people are formed from among the full-time finalists of the Competition based on the principle of including representatives of different countries, cities, and universities in one project group;
  - teams receive tasks on the development of new methods for assessing financial behavior and the formation of practical skills for a certain category of citizens.
  - the work of the project teams on the implementation of the received tasks of the competition;
  - consultations with experts on financial literacy.
  - 3.2.2. THIRD STAGE (final):
  - face-to-face defense of projects;
  - determination of the winning team and prize-winning teams of the Contest.

### 4. Requirements for tender documentation and rules of registration of competitive works

At the first stage Participants of the Contest should send them to the Organizing Committee of the Contest in electronic form via a special registration form on the EEYF website <a href="www.eurasia-forum.ru">www.eurasia-forum.ru</a>. the following package of documents:

- 1) Participant's application form (Appendix 1) submitted by filling out the participant's registration form on the EEYF website.
- 2) A file with a description of a project developed by a participant to improve financial literacy of a certain category of citizens. The project requirements are specified in Appendix 2.

#### 5. Procedure and criteria for evaluating works

- 5.1. The requirements and criteria for evaluating videos are set out in Appendix 2.
- 5.2. Project work команд-участникоf participating teams should include:
- Match the general parameters of the issued task.
- Contain a professional, creative, and innovative component.
- Have the possibility of practical application.

When determining the winners of the Competition, preference is given to projects that demonstrate the practical feasibility and social significance of the issues raised, the possibility of scaling, originality of thinking, creative understanding of existing approaches to solving the problems raised, and the possibility of using project work (ideas) in financial literacy activities.

#### **6.** Managing the Contest

- 6.1. The Competition is managed by the EEYF Directorate and the Competition Organizing Committee.
- 6.2. To organize and conduct the contest, the Organizing Committee is formed, approved by the order of the USUE Rector. The Organizing Committee consists of:
  - Chairman of the EEYF Organizing Committee;
  - Co-chairman of the EEYF Organizing Committee;
  - scientific director of the Competition;
  - Contest coordinator(s);
  - chairman and members of the expert commission of the Contest;
  - representatives of the Contest partner organizations,
  - Competition Secretary.
- 6.3. The Organizing Committee provides general management of the organization and conduct of the Contest.
  - 6.3.1. Chairman of the Organizing Committee:
- approves the Regulations on the Competition, signs the order on holding the Competition and the composition of the organizing committee of the Competition, the order on the composition of the expert commission;
- provides general management of the organization and conduct of SEFM events, within the framework of which the Competition is held.
  - 6.3.2. Co-Chairman of the Organizing Committee:
- directly manages the organization and conduct of the EEYF, together with the scientific director of the Competition, forms the composition of the expert commission of the Competition.
  - 6.3.3. An expert commission is created to conduct an expert assessment of competitive works.

The chairman of the expert committee is the director of the EEYF Congress, which hosts the Koncourse. The expert committee consists of highly qualified teachers and researchers, leading experts from among the organizers of the EEYF, as well as invited experts. More than half of the members of the expert commission must be representatives of third-party organizations. Decisions of the expert commission are recorded and signed by the chairman, secretary and members of the expert commission (Appendix 3 and Appendix 4).

- 6.3.4. Scientific Supervisor of the Contest:
- prepares the draft Regulations on the Competition and submits them to the rector for approval, prepares amendments and additions to it;
  - co-chairs the expert committee of the Contest
  - selects the composition of the expert commission of the Contest.
  - 6.3.5. Contest Coordinator:
  - ensures the invitation of members of the expert commission of the Contest
- organizes distribution of informational letters to educational, research and scientific organizations of the Russian Federation and Eurasian countries;
- organizes registration and verification of compliance of the received tender documents with the established requirements, sends the competition works to the members of the expert commission for evaluation;

- organizes and monitors the progress of the Contest;
- organizes a master class for the second group of participants;
- organizes the final and the work of the expert commission during the third stage of the Competition;
- organizes registration of diplomas and awarding of winners and prize-winners of the Competition;
  - prepares a report on the Contest.
- 6.4. Information about the composition of the organizing committee and expert commission are published annually on the Contest page of the EEYF website.
- 6.5. To organize the Competition at the regional or foreign site of the XII SES, an organizing committee of the site is created. It includes:
  - site manager rector of the university;
  - scientific director of the Site Competitionand-is the chairman of the site's expert commission;
  - members of the site's expert commission;
  - site Competition coordinator.

#### 7. Awarding of winners

7.1. Based on the results of the final round, the winning team and prize-winning teams of the Competition are determined.

All members of the winning and prize-winning teams Participants of the competition are awarded with Diplomas of I, II, III degrees and orders for 1,2, and 3 places, respectively. Winners and prize-winners Participants of the Competition also receive cash prizes within the Competition prize fund established by the order of the USUE Rector.

Cash prizes are divided between all team members in equal shares and, taking into account the payment of income tax, are transferred by the organizer Конкурса To the personal accounts of the winners and prize-winners within 1.5 months according to the details provided to the Contest coordinator. Cash prizes for foreign participants are issued at the USUE cash desk on the day of awarding.

7.2. All participants of the final stage of the Competition receive certificates of finalists of the Competition.

### Criteria for evaluating a video clip (points).

The maximum number of points for a competitive work is 15.

Criteria	Description	Score
Technical level	- the video runs for at least 1 and no more than 3 minutes; - advanced features of the video creation program are used, frames change clearly (enough time to read subtitles (if available) or view the picture); - camerawork skills (shooting quality, sound quality); - synchronization of music and images; - video transitions.	5 points
Language level	Content: Full disclosure of the topic. The language design of the video and the video sequence fully reveals the idea of the authors. Statements and frames are synchronous, logical, and consistent. Organization: An entry is available. Availability of a conclusion. Logical presentation of information. Language design: A variety of vocabulary is used. There are no grammatical errors. Live speech is valued more than captions.	5 points
Artistic level and originality	- originality of the script (originality of the idea and content of the work, creative novelty); - direction; - selection of music; - the image is clear, the contrast is used correctly, the frames are selected according to the topic; - the order of presentation of information is logical and serves to achieve a certain artistic effect.	5 points
