1. General provisions

- 1.1. This Regulation (hereinafter referred to as the Regulation) regulates the organization and conduct of the International Online Olympiad "Economics and Finance of the Polycentric World" (hereinafter referred to as the Olympiad).
- 1.2. The Olympiad is held within the framework of the Congress of Economists and Financiers of the Eurasian Economic Youth Forum (hereinafter EEYF). The Internet address of the EEYF website www.eurasia-forum.ru
 - 1.3. Organizer of the Olympiad:

Ural State University of Economics (USUE), Institute of Economics and Finance, Department of World Economy and Foreign Economic Activity

1.4. Co-organizers of the Olympiad:

Foreign and regional EEYF sites that have chosen this Olympiad for implementation on their sites. The list of foreign and regional sites that have chosen this Olympiad is indicated on the Olympiad page of the Congress of Economists and Financiers of the EEYF website, as well as on the foreign/regional Sites of the EEYF website themselves.

- 1.5. Olympiad Partners:
- Rostov State University of Economics, Rostov-on-Don;
- Ural Branch of the Free Economic Society of Russia, Yekaterinburg.
- 1.6. The purpose of the event is to increase the interest of young people in obtaining and building up economic knowledge by revealing their abilities for economic analysis and propensity for economic thinking, conducting meta-subject links between economic, political and social processes.
 - 1.7. Objectives of the Olympiad:
 - to stimulate young people to new ideas, proposals, dialogue between countries and peoples;
 - to stimulate the interest of young people in the economic processes taking place in the world;
- to promote the formation of motivation to acquire systematic knowledge in the field of economics and finance;

2. Conditions of participation in the Olympiad, registration of participants

- 2.1. Students, undergraduates, postgraduates, persons interested in modern problems of economics and finance, under the age of 35, are invited to participate in the Olympiad.
 - 2.2. Participation in the Olympiad is individual.
- 2.3. Applications for participation in the Olympiad are accepted through the registration system of the EEYF website www.eurasia-forum.ru, at the Congress of Economists and Financiers (Appendix 1).

For participants of the Olympiad, representatives of foreign/ regional sites, the application is registered from the page of the foreign/regional site of the EEYF website.

- 2.4. Applications for participation are submitted within the deadline specified on the Olympiad page of the EEYF website.
 - 2.5. There is no registration fee for participation in the Olympiad.

3. Stages and dates of the Olympiad

- 3.1. The Olympiad is an annual event. The specific dates of the Olympiad, as well as its main stages, are established by the order of the Rector of the Ural State University of Economics (USUE).
 - 3.2. The Olympiad is held in two stages.
- 3.2.1. The first stage is registration of participants and verification of compliance with the requirements for participants of the Olympiad (section 2 of this Regulation).

The first stage is held by the organizing committee of the Olympiad within the deadlines set by the Directorate of the Eurasian Economic Youth Forum and published on the EEYF website.

3.1.2. The second (final) stage is held remotely, on the main competition day of the Forum, in the form of testing performed by participants on a specialized Olympiad website. The e-mail address of the participant specified during registration on the EEYF website is sent in advance to the address of a specialized website, instructions for completing tasks.

On the main competition day of the Forum, access to tasks opens. The test task execution time is 60 minutes. The number of questions is 40. The number of attempts to pass is 1.

According to the results of the testing, three winners are determined, who took I, II and III places respectively in terms of the number of points scored.

The list of winners of the Olympiad is published on the Olympiad page of the EEYF website.

4. The order of the final and the criteria for evaluating the Olympiad tasks of the participants

- 4.1. The second (final) stage of the Olympiad includes professional test tasks on economic and financial issues related to modern economic, political and social development trends and transformational changes in world economic processes. The number of questions is 40. The number of attempts to pass the test is 1. The correctness of the answers to the test questions is evaluated. 1 point is given for the correct answer to each question, the maximum number of points is 40. In the case of a set of the same number of points, the time of passing the test will be taken into account; priority will be given to the participant who completed the test faster.
- 4.2. All tasks provide for the assessment of the implementation of professional competencies within the disciplines: "World Economy", "Foreign Economic activity", "National Economy", "Regional Economy", "Macroeconomics", "Money, credit, Banks", "Finance", "Political Science", etc.
- 4.3. An expert commission of the Olympiad is created to conduct an expert evaluation of the works. All decisions of the expert commission are recorded and signed by the chairman, secretary of the expert commission.
- 4.4. The lists of winners are published on the Olympiad page and information letters on the results of the Olympiad are sent by e-mail.

5. Olympiad Management

5.1. The Olympiad is managed by the Directorate of the EEYF and the Organizing Committee of the Olympiad.

- 5.2. For the organization and holding of the Olympiad, an Organizing Committee is formed, approved by the order of the Rector of USUE. The Organizing Committee consists of:
 - Chairman of the EEYF;
 - Co-Chairman of the EEYF:

Members of the organizing committee:

- Scientific director of the Olympiad;
- coordinator(s) of the Olympiad;
- Chairman and members of the expert commission of the Olympiad;
- representatives of partner organizations of the Olympiad,
- Secretary of the Olympiad.
- 5.3. The Organizing Committee provides general management of the organization and conduct of the Olympiad.
 - 5.3.1. The Chairman of the Organizing committee:
- approves the Regulations on the Olympiad, signs the order on the holding of the Olympiad and the composition of the Organizing committee of the Olympiad, the order on the composition of the expert commission;
- carries out general management of the organization and conduct of the events of the EEYF, within which the Olympiad is held.
 - 5.3.2. Co-Chairman of the Organizing Committee:
- directly manages the organization and conduct of the EEYF, together with the scientific director of the Olympiad forms the composition of the expert commission of the Olympiad.
 - 5.3.3. An expert commission is created to conduct an expert assessment of the participants.

The chairman of the expert commission of the Olympiad is the director of the EEYF Congress, in which the Olympiad takes place. The expert commission consists of highly qualified representatives of the scientific and business community; Russian and foreign experts in the field of economics and finance from higher educational institutions of the Russian Federation, countries of the Near and far Abroad, academic science, audit companies; business practitioners. More than half of the members of the expert commission must be representatives of third-party organizations.

The expert commission also includes representatives of the co-organizing countries that have chosen this Olympiad for implementation at their foreign/regional venues.

All decisions of the expert commissions are recorded and signed by the chairman (co-chairman), secretary and members of the expert commission (Appendix 2).

- 5.3.4. Scientific Supervisor of the Olympiad:
- prepares draft Regulations on the Competition and submits it to the rector for approval,
 prepares amendments and additions to it;
 - − is the co-chairman of the expert commission of the Olympiad;
 - selects the composition of the expert commission of the Olympiad;
- approves tasks for the participants of the Olympiad from the chairman of the expert commission.
 - 5.3.5. Coordinator(s) of the Contest:
 - provides an invitation to the members of the expert commission of the Olympiad;
- organizes the mailing of informational letters to educational, research and scientific organizations of the Russian Federation and foreign countries;

- ensures the operation of a specialized website for the qualifying round of the Olympiad;
- organizes the final and the work of the expert commission during the final of the Olympiad;
- organizes the registration of diplomas and awarding of winners and prize-winners of the Olympiad;
 - draws up a report on the Olympiad.
- 5.3. Information about the composition of the organizing are published annually on the Olympiad page of the EEYF website.

6. Awarding of winners

6.1. According to the results of the final round, the winner and prize-winners of the Olympiad are determined. They are awarded Diplomas of I, II, III degrees and orders for 1,2, and 3rd place, respectively. The participants who took 4th and 5th places are also determined. They are awarded with diplomas for the 4th and 5th places.

All participants of the final round receive certificates of the Olympiad finalists. And when was the selection for the final? After all, you only have a competition once?

All participants of the Olympiad who scored more than 50% correct answers to the Olympiad tasks receive certificates of participants of the Olympiad.

Among the participants who participated through foreign/regional sites, the 1st to 5th places of foreign / regional sites are determined.

6.2. The winners and prize-winners of the Olympiad are awarded with cash prizes within the prize fund of the Olympiad, established by the order of the Rector of USUE and in accordance with the protocol of the expert commission of the Olympiad.

Cash prizes (including income tax) are transferred by the organizer of the Olympiad within 1.5 months to the personal accounts of the winners and prize-winners according to the details provided to the coordinator of the Olympiad.

6.3. In case of receiving the same number of points, the time of passing the test will be taken into account; priority will be given to the participant who completed the test faster.
