1. General provisions

- 1.1. This Regulation (hereinafter referred to as the Regulation) regulates the procedure for organizing and holding the International Championship in Website Building "IT-Constructor" (hereinafter referred to as the Competition).
- 1.2. The competition is held within the framework of the Congress of Innovators of the Eurasian Economic Youth Forum (hereinafter EEYF).
 - 1.3. Competition Organizers:

"Ural State University of Economics" (USUE), Scientific and Educational Center for Information Technologies.

1.4. Co-organizers of the Competition:

Universities-organizers of foreign and regional EEYF sites that have chosen this competition for implementation on their sites. The list of foreign and regional sites that have chosen this Competition is indicated on the Competition page of the Congress of Innovators of the EEYF website, as well as on the foreign/regional Sites of the EEYF website themselves

- 1.5. The purpose of the competition is to promote the implementation of creative initiatives of young professionals in the field of website building, web development, analytics.
 - 1.6. Tasks:
- Identification of talented youth and determination of further prospects for their further development;
- Involving young people in the process of designing, designing, launching and analyzing the website;

Analysis of positive and negative factors in the development of projects;

• Identification and provision of the best practices of organizational construction of management systems, implementation of corporate ethics and culture based on the analysis of the processes and results of the development team.

2. Subject of the Competition

The subject of the competitive evaluation is a website developed within the allocated time of the competition by the participating team on a given topic.

3. Terms of participation in the Competition

- 3.1. Teams consisting of students of all forms of education, graduate students, scientists from educational organizations, academic institutions and other interested organizations in Russia and foreign countries under the age of 35 years old (hereinafter referred to as Participants), no more than 4 people are allowed to participate in the Competition.
 - 3.2. Each participant must register on the official website of the EEYF.
- 3.3. There is no registration fee. Expenses for accommodation of non-resident participants, food and transportation costs for participation in the full-time stage of the competition are paid independently by the participants or organizations.

4. Stages and terms of the Competition

- 4.1. The competition is an annual event. The final dates for the Competition, as well as its main stages, are established by the order of the rector of the Ural State University of Economics.
 - 4.2. The competition is held in two stages.
- 4.2.1. The first stage is the acceptance and registration of applications for participation in the competition.

The first stage is carried out within the time frame set by the Directorate of the Eurasian Economic Youth Forum. Lists of teams participating in the second (full-time) round are posted on the Competition page of the EEYF website. If a team member for any reason cannot take part in the Competition in person, the team captain may replace him with another participant who meets the requirements of Section 3 of the Regulations.

- 4.2.2. The second stage (full-time), consists in the creation of a site on a topic chosen from the topics proposed by the organizers, the definition of winners and prize-winners.
- 4.3. Participation in the competition is also possible using distance technologies registered participants get access to USUE cloud resources based on the MS Office 365 platform and connect to interactive sessions within the events through teams created in Microsoft Teams.

5. Participants Registration Requirements

5.1. At the first stage of the Competition, participants submit an application for participation in the Competition electronically through the registration form on the EEYF website www.eurasia-forum.ru.

For the participants of the Competition, representatives of foreign/regional sites, the application is registered from the page of the foreign/regional site of the EEYF website.

Participant's application (Appendix 1) are submitted by filling out the registration form on the EEFM website by each team member. At the same time, the team captain is registered as "captain" and in the registration form in the "topic of work" section indicates the name of the team / team motto. The rest of the team members are registered as team members, indicating the team name / team motto in the "topic of work".

5.2. The application (registration) of participants is submitted within the period specified on the EEFM website.

6. The procedure for holding the Competition and the criteria for evaluation of works

- 6.1. During the first stage, the organizing committee evaluates the teams' applications for compliance with the requirements.
- 6.2. During the second (full-time) stage of the Competition, the expert commission of the competition evaluates the final work of the Competitionants the created site according to the following criteria:
 - practical feasibility and social significance 30 points;
 - creative realization (design) 30 points;
 - originality of thinking 20 points;
 - site presentation 20 points.
 - 6.3. The expert committee makes a decision based on the total points.
- 6.4. If the winners and prize-winners of the Competition have the same number of points, the decision to determine the winners and prize-winners remains with the expert commission of the Competition.

6.5. The expert commission has the right to award special nominations to individual commands.

7. Competition Management

Regulation

- 7.1. The Competition is managed by the EEYF Directorate and the Organizing Committee of the Competition.
- 7.2. To organize and conduct the competition, an Organizing Committee is formed, approved by the order of the rector. The Organizing Committee consists of:
 - chairman;
 - co-chairman:

Members of the organizing committee:

- scientific supervisor of the Competition;
- coordinator(s) of the Competition;
- Chairman and members of the expert commission of the Competition;
- representatives of organizations partners of the Competition,
- competition secretary.
- The Organizing Committee carries out general management of the organization and conduct of the Competition.
 - 7.3.1. Chairman of the Organizing Committee:
- approves the Regulations on the Competition, signs the order on the holding of the Competition and the composition of the Organizing Committee of the Competition, the order on the composition of the expert commission of the Competition;
- carries out general management of the organization and conduct of EEYF events, within the framework of which the Competition is held.
 - 7.3.2. Organizing committee co-chair:
- carries out direct management of the organization and conduct of the EEYF, together with the Scientific Supervisor of the Competition, forms the composition of the expert commission of the Competition.
- 7.3.3. An expert commission of the Competition is created to conduct an expert assessment of the competitors works.

The chairman of the expert commission of the Competition is the director of the Congress, within the framework of which the Competition is held. The expert commission of the Competition includes highly qualified teachers, leading scientists and specialists from the organizers of the EEYF, the Competition, as well as invited experts. The composition of the expert commission is from 5 to 7 people, including more than half of them should be representatives of third-party organizations. The decisions of the expert commission are recorded, the protocols are signed by the chairman, secretary and members of the expert commission (Appendix 3)

- 7.3.4. Scientific Supervisor of the Competition:
- prepares a draft Regulation on the Competition and submits it for approval to the rector, prepares changes and additions to it;
 - a co-chairman of the expert commission of the Competition;
 - selects the composition of the expert commission of the Competition;
- develops and approves the competition tasks for the participants with the chairman of the expert commission.
 - 7.3.5. The Competition Coordinator, together with his assistant and the working group:
 - ensures the invitation of members of the expert commission of the Competition;

- sends information letters to educational, research and scientific organizations of the Russian Federation and other countries;
- organizes the registration and verification of the compliance of the received tender documents with the established requirements;
 - organizes the holding of the final and the work of the expert commission of the Competition;
- organizes the issuance of diplomas, certificates and awarding the winners and prize-winners of the Competition;
 - draws up a report on the Competition.

8. Awarding winners

8.1. According to the decision of the expert commission, winners and prize-winners are determined, they are awarded with Diplomas of I, II, III degrees and orders for 1,2, and 3rd place, respectively.

All participants receive certificates of finalists of the Competition.

8.2. The winners and prize-winners are awarded cash prizes within the prize fund of the Competition, established on the basis of the order of the rector of USUE and in accordance with the protocols of the expert commissions of the Competition.

In the event that the winner or prize-winner of the Competition is the team of authors (team), the cash prize is divided among all members of the team (team) in equal shares.

Cash prizes (including income tax) are transferred by the founder of the Competition within 1.5 months to the personal accounts of the winners and prize-winners according to the details provided to the Competition coordinator, with the timely provision of copies of the necessary documents. Cash prizes are given to foreign participants at the USUE box office on the award day.
