1. General regulations

- 1.1. This Regulation (hereinafter referred to as the Regulation) regulates the procedure for holding the international scientific competition "Methods for protecting the rights and freedoms of human and citizen" (hereinafter referred to as the Competition).
- 1.2. The competition is held within the framework of the Congress of Strategists of the Eurasian Economic Youth Forum (hereinafter referred to as the EEYF). Internet address of the EEYF website www.eurasia-forum.ru
 - 1.3. Competition Organizer:

Federal State Budgetary Educational Institution of Higher Education "Ural State University of Economics" (USUE) represented by the Department of Constitutional and International Law.

1.4. Co-organizers of the Contest:

Universities are the organizers of foreign and regional EEYF sites that have chosen this competition for implementation on their sites. The list of foreign and regional sites that have chosen this Competition is indicated on the Competition page of the Congress of Economists and Financiers of the EEYF website, as well as on the foreign/regional Sites of the EEYF website themselves

- 1.5. Competition Partners:
- Statutory Court of the Sverdlovsk Region;
- FGBOU VO "Novosibirsk State University of Economics and Management" "NINH" (NSUEU).
- 1.6. The purpose of the competition is to realize the creative potential of young people in solving the problems of improving and developing the current legislation; increasing the interest of young people in the problems of protecting the rights and freedoms of citizens; facilitating the exercise of citizens' rights to judicial protection; attracting young people to public administration through their participation in the discussion of topical legal problems; promoting the dissemination and development of legal culture among the youth; selection of promising projects for the preparation of law-making initiatives; selection of promising works for participation in other competitions at the regional and
 - 1.7. Competition objectives:
 - to identify the analytical potential of young lawyers, economists and managers;
 - -to stimulate the process of exchange of knowledge, ideas, experience in the use of mechanisms of legal regulation of public relations;
 - to ensure the integration of youth science with the global research environment.

2. Scientific directions of the Competition

- 2.1. The topic of the essay is determined independently, taking into account the scientific direction of the competition "Ways to protect the rights and freedoms of human and citizen."
 - 2.2. Essays are submitted to the competition in the following areas:
 - 1. "Implementation and protection of the rights of citizens in the field of education."
 - 2. "Tactics of working with a client in human rights activities."
 - 3. "Realization and protection of the rights of minors on the Internet."

3. Terms of participation in the Competition

3.1. Students of educational organizations, academic institutions and other interested organizations in Russia and foreign countries under the age of 35 years old (hereinafter referred to as Participants) are invited to participate in the Competition.

Works prepared by young scientists - graduate students and candidates of sciences, are not accepted for the competition.

- 3.2. One participant (one team) has the right to submit only one essay to the Competition.
- 3.3. Essays of participants who do not meet these requirements will not be accepted for participation in the competition.
- 3.4. There is no registration fee for participation in the competition. Expenses for accommodation of non-resident participants, food and transportation costs for participation in the fulltime stage of the competition are paid by the participants themselves, or by sending organizations.

4. Procedure and terms of the Competition

4.1. The competition is held in three stages.

The first stage is carried out by the Organizing Committee of the Competition within the time limits set by the Directorate of the Eurasian Economic Youth Forum.

The second stage, the examination of the essay, is carried out by the expert commission of the Competition and the expert commissions of foreign sites of the Competition. According to the results of the examination, lists of Participants who have passed to the final of the Contest are formed. Lists of finalists are published on the Competition page of the EEYF website. The second stage - (qualifying), is

The third stage is the (final) defense and presentation of the scientific essays of the finalists, the determination of the winners of the Competition. It is held simultaneously at USUE and at foreign sites of the Competition using online communication.

The third stage is held between the finalists of the Competition by public defense of the essay.

5. Requirements for the submitted documentation and essay writing rules

- 5.1. Essays are submitted to the Organizing Committee of the Competition in electronic form through a special registration form on the EEYF website www.eurasia-forum.ru.
 - 5.2. To participate in the Competition, the following package of documents must be submitted:
- 1) the author's application for participation in the Competition (Appendix 1) submitted by filling out the registration form of the participant on the EEYF website. If the essay is prepared by a team of authors, one of the authors is registered as a team captain and attaches an essay, the rest of the participants are registered as team members, without attaching an essay;

For the participants of the Competition, representatives of foreign/ regional sites, the application is registered from the page of the foreign/regional site of the EEYF website.

2) the text of the essay with the title page (Appendix 2) - attached as a separate file to the registration form of the participant.

- 5.3. The essay must meet the following requirements:
- Essay volume from 2 to 3 pages of computer text, no more than 2500 characters with spaces;
- the essay must correspond to one of the topics;
- the essay written by the participant should reveal the issues, as well as contain practical innovative ideas for the development of the protection of human and civil rights and freedoms within the framework of the chosen topic.

6. Contest Management

- 6.1. The Competition is managed by the EEYF Directorate and the Organizing Committee of the Competition.
- 6.2. To organize and conduct the competition, an organizing committee is formed, approved by the order of the rector of USUE. The organizing committee includes: - Chairman - Rector of USUE;

 - co-chairs USUE Vice-Rector for Social Work, USUE Vice-Rector for Research; organizing committee members:
- Scientific Supervisor of the Competition Head of the Department of Constitutional and International Law;
- Coordinator of the Competition Lecturer of the Department of Constitutional and International Law;
 - Chairman and members of the expert commission of the Competition;
 - representatives of organizations partners of the Competiton,
- Secretary of the Competition an employee of the Department of Constitutional and International Law.
- 6.3. The Organizing Committee carries out general management of the organization and conduct of the Competition, and also performs the following functions:
- sending information letters to universities and organizations of the Russian Federation and other countries, no later than three months before the final stage;
- acceptance and organization of essay processing, as well as registration of mandatory and additional documentation of participants - no later than 15 days before the start of the final, third, stage
- examination of essays by expert commissions within the framework of the second stage, no later than 10 days before the start of the final, third, stage of the Competition;
- distribution of information letters to educational and scientific organizations of the Russian Federation and other countries, notifying young scientists and students about the entry into the third
- formation and publication of the Competition program and/or the EEYF program with information about the Competition;
 - holding the third stage (final) of the Competition;
 - Winner's reward ceremony.
 - 6.3.1. Chairman of the Organizing Committee:

- approves the Regulations on the Competition, signs the order on holding the Competition and the composition of the Organizing Committee of the Competition, the order on the composition of the expert commissions of the Competition directions;

carries out general management of the organization and conduct of the Competition events.

6.3.2. Organizing committee co-chair:

- directly manages the organization and conduct of the EEYF, within which the Competition is held, is the chairman of the expert commission of the Competition (area of the Competition), together with the scientific supervisor of the Competition, form the composition of the expert commission of the Competition (area of the Competition).
- 6.3.3. The composition of the expert commission of the Competition (direction of the Competition) includes highly qualified teachers, leading scientists and specialists from the organizers of the EEYF, the Competition, as well as invited experts from universities, academic institutions, other organizations and institutions. The number of members of expert commissions is from 3 to 5 people, including more than half of them are representatives of third-party organizations. The list of members of expert commissions is published on the Competition page of the EEYF website.

6.3.4. Scientific Supervisor of the Competition:

- prepares a draft Regulation on the Competition and submits it for approval to the rector, prepares changes and additions to it;
 - is a co-chair of the Competition;
- selects the composition of the expert commission of the Competition (direction of the Competition);
 - 6.3.5. The Competition Coordinator, together with his assistant and the working group:
 - ensures the invitation of members of the expert commission of the Competition;
 - sends information letters to universities of the Russian Federation and Eurasian countries;
- organizes the registration and verification of the received essays according to the established requirements, sends the essay to the members of the expert commission for evaluation;
 - organizes and controls the course of the Competition;
 - organizes the work of the expert commission during the third stage of the Competition;
- organizes the issuance of diplomas and the awarding of winners and prize-winners of the Competition;
- organizes the collection of abstracts of the finalists of the Competition and their transfer to the USUE Publishing House for inclusion in the collection of materials of the EEYF;
 - draws up a report on the Competition.
- 6.3.6. The Scientific supervisor, coordinator(s), as well as members of the expert commission of the Competition are published annually on the Competition page of the EEYF website.

7. The procedure and criteria for evaluating an essay

7.1. The Organizing Committee selects essays for further expert evaluation according to the requirements specified in paragraph 5 of the Regulations.

An expert commission is created to conduct an expert assessment of the work. All decisions of the expert commissions are recorded and signed by the chairman, secretary and members of the expert

- 7.2. During the second (qualifying) stage, the expert commission of the Competition and the expert commissions of foreign sites of the Competition conduct an examination of the scientific essays of the participants and determine 20 finalists, including 5 finalists from each foreign site.
- The lists of finalists are posted on the page of the Competition and information letters about reaching the final are sent to the finalists. If the finalist for any reason cannot take part in the final in person, by decision of the Organizing Committee of the Competition, he may be allowed to participate online or be excluded from the list of finalists by entering the participant who took the next place in the final round according to the results of the qualifying round.

Criteria for evaluating competitive works at the second (qualifying) stage:

- 1) Correspondence of the content to the chosen topic 10 points;
- 2) Completeness of disclosure of the chosen topic 10 points;
- 3) The presence in the work of the position of its author 10 points;
- 4) Argumentation of the proposed thesis of the work 10 points;
- 5) The presence in the work of practical ideas for the development of a system for protecting the rights and freedoms of human and citizen - 10 points;
- 6) General erudition, knowledge in the field of law 10 points;
- 7) Creativity author's elements in the work, original approach to the presentation of material -
- 8) Clarity and consistency of presentation 10 points;
- 9) Validity of conclusions 10 points;
- 10) Speech design of the essay and semantic integrity 10 points.
- 7.4. During the third (final) stage, members of the expert commissions fill out an expert list for each finalist of the Competition.

Criteria for evaluating participants during full-time defense of work at the third (final) stage:

- 1) logical and persuasive presentation up to 10 points
- 2) presentation up to 10 points;
- 3) defense (answers to experts' questions) up to 30 points.
- 7.5. To determine the results, the scores of the qualifying and final stages are summed up. The maximum total score is 150 points.

8. Awarding of winners

8.1. Based on the results of full-time defense, the winners and prize-winners of the competition are determined, they are awarded with Diplomas of I, II, III degrees and orders for 1, 2, and 3 places,

Participants who take 4th and 5th places are awarded with Diplomas for 4th and 5th places respectively. All participants of the third stage of public defense of projects receive certificates of finalists of the Competition, scientific supervisors receive letters of thanks.

8.2. The winners and prize-winners are awarded cash prizes within the prize fund of the Competition, established on the basis of the order of the rector of USUE and in accordance with the protocols of the expert commissions of the Competition.
