1. General Provisions

1.1. These Regulations (hereinafter referred to as the Regulations) regulate the procedure for organizing and holding the International Championship in website building "IT Constructor" (hereinafter referred to as the Competition).

1.2. The competition is held within the framework of the Congress of Innovators of the Eurasian Economic Youth Forum (hereinafter referred to as EEYF) and is implemented at the main site of EEYF - at the Ural State University of Economics (hereinafter referred to as the USUE site), as well as at foreign and regional sites of EEYF that have chosen this Competition for implementation on their sites. The list of foreign and regional sites that have chosen this Competition is indicated on the Competition page of the Congress of Innovators of the EEYF website, as well as on the pages of the foreign/regional sites themselves on the EEYF website.

1.3. Organizer of the Competition:

" Ural State University of Economics" (USUE), Scientific and Educational Center for Information Technologies.

1.4. Co-organizers of the Competition:

Universities-organizers of foreign and regional EEYF platforms that have chosen this competition for implementation at their sites.

- 1.4. The goal of the competition is to promote the implementation of creative initiatives of young professionals in the field of website building, web development, and analytics.
 - 1.5. Tasks
- Identification of talented youth and determination of further prospects for their further development;
- Involving young people in the process of designing, designing, launching and analyzing the website;

Analysis of positive and negative factors in project development:

• Identification and provision of best practices for organizational construction of management systems, implementation of corporate ethics and culture based on an analysis of the processes and results of the development team.

2. Subject of the Competition

The subject of the competitive assessment is an Internet site on a given topic developed within the allotted time of the competition by the participating team.

3. Conditions of participation in the Competition

- 3.1. Teams consisting of students of all forms of study, graduate students, scientists from educational organizations, academic institutions and other interested organizations in Russia and foreign countries under the age of 35 (hereinafter referred to as Participants), consisting of no more than 4 people, are allowed to participate in the Competition.
- 3.2. Young scientists who are candidates of science are not allowed to participate in the competition.

3.3. Each participant must register on the official website of the EEYF.

3.4. There is no registration fee. Expenses for accommodation of non-resident participants, food and transportation costs for participation in the full-time stage of the competition are paid independently by the participants or organizations.

4. Stages and timing of the Competition

- 4.1. The competition is an annual event and is held during the summer semester. The final dates for the Competition, as well as its main stages, are established by order of the rector of the Ural State University of Economics and are posted on the Competition page of the EEYF website.
 - 4.2. The competition is held in two stages.
- 4.2.1. The first stage (until March 20, 2024 inclusive) acceptance and registration of applications for participation in the Competition; checking for compliance with the requirements for participants.

The first stage is carried out by the organizing committees of the Competition of the relevant sites:

- Organizing Committee of the USUE Main Site Competition;
- organizing committees of the Competition of foreign/regional sites.

There is no qualifying round for participants in this Competition. All participants who meet the requirements of Section 3 of the Regulations participate in the finals of the Competition.

4.2.2. Second phase (April 24-25, 2024) – (face-to-face or remote format), consists of completing work to create a website on a topic chosen from those proposed by the organizers within a certain time; determination of winners and prize-winners of the Competition; rewarding the participants.

For participating teams from foreign/regional sites of the Competition, participation is organized using remote technologies - registered participants receive access to USUE cloud resources based on the MS Office 365 platform and connect to interactive sessions within the events through teams created in Microsoft Teams. The presence of a camera and microphone for participants taking part remotely is a mandatory condition of the competition.

By decision of the Organizing Committee of the Competition, individual participants studying in other regions of the country may also be given the right to participate online.

Based on the results of the expert examination of the work, the winner and prize-winners of the Competition are determined, taking 1st, 2nd and 3rd places, respectively, by the number of points scored

At the same time, winners and runners-up (1st, 2nd and 3rd place) of each foreign/regional site of the Competition are determined. They are determined by the number of points scored among site participants.

On April 25, 2024, there will be an in-person awards ceremony for the winners and prize-winners of the Competition as a whole at USUE and the winners and prize-winners of national/regional rounds on the territory of the base universities. The simultaneous awards ceremony will be broadcast via video conferencing.

5. Registration of participants

5.1. At the first stage of the Competition, participants submit an application for participation in the Competition electronically through the registration form on the EEYF website www.eurasia-forum.ru.

Participant's application (Appendix 1) - submitted by filling out the registration form on the EEYF website by each team member.

In this case, one of the team members is registered as "team captain" and in the registration form in the "topic of work" section indicates the team name/team motto. The rest of the team members register as a "team member", indicating the team name/team motto in the "topic of work".

If a team member for any reason cannot take part in the Competition in person, the team captain may replace him with another participant who meets the requirements of Section 3 of the Regulations.

5.2. Application (registration) of participants is submitted on time until March 20, 2024, or otherwise indicated on the website of the EEYF Congress of Innovators Competition.

6. Criteria for evaluating competition works

- 6.1. During the second (in-person) stage of the Competition, the expert commission of the competition evaluates the final work of the competitors the created website according to the following criteria:
 - practical feasibility and social significance 30 points;
 - creative implementation (design) 30 points;
 - originality of thinking 20 points;
 - website presentation 20 points.
 - 6.3. The expert commission makes a decision based on the sum of points.
- 6.4. If the winners and runners-up of the Competition have the same number of points, the decision to determine the winners and runners-up remains with the Expert Commission of the Competition.
 - 6.5. The expert commission has the right to award individual teams with special nominations.

7. Winner's reward ceremony Competition

7.1. Based on the results of the public defense of the project, the winners and prize-winners of the Competition are determined, they are awarded Diplomas of 1st, 2nd, 3rd degree and large orders "Star of Eurasia" for 1st, 2nd, and 3rd place, respectively.

Participants who took 4th and 5th places in the Competition are awarded Certificates for 4th and 5th places, respectively. All participants in the third stage - public defense of projects - receive certificates of finalists of the Competition in electronic form.

7.2. The winners and runners-up of the Competition are awarded cash prizes within the framework of the Competition prize fund, established on the basis of the order of the USUE Rector and in accordance with the protocol of the Competition expert commission.

The amount of the cash prize established for 1st, 2nd or 3rd place is published on the Competition page of the EEYF website and is divided between team members in equal shares.

Cash prizes (including payment of income tax) are transferred by the Competition organizer within 1.5 months to the personal accounts of winners and prize-winners using the details provided

to the Competition coordinator, subject to the submission of the following documents to the Competition organizer:

- printout from the bank's personal account: bank details and personal account number for transferring money;
 - a copy of the passport page 1, 2 and page with registration;
 - a copy of the TIN or a printout of the TIN data from the website.

Cash prizes for foreign participating teams that took 1st, 2nd or 3rd place in the finals of the Competition are transferred according to the details of the bank that is the partner bank of the Russian bank. The cash prize is transferred to the captain of the foreign team for the entire team.

- 7.3. Participants of foreign/regional sites who took 1st, 2nd and 3rd places among the participants of their site are awarded certificates for 1st, 2nd and 3rd places of the Competition sites and small orders "Star of Eurasia".
- 7.4. The awarding of all finalists of the Competition will take place as part of the final events of the XIV EEYF on April 25, 2024 simultaneously at the USUE site and at foreign/regional Competition sites using online communication.

8. Management of the Competition on the USUE site

- 8.1. The Competition is managed by the EEYF Directorate and the Organizing Committee of the Competition.
 - 8.2. Chairman of the EEYF Organizing Committee Rector of USUE:
- approves the Regulations on the Competition, signs the order on holding the Competition and the composition of the organizing committee of the Competition, the order on the composition of the expert commission of the Competition;
- carries out general management of the organization and conduct of EEYF events within the framework of which the Competition is held.
- 8.3. To organize and conduct the Competition, an organizing committee of the Competition is formed, which includes:
 - scientific director of the Competition;
 - Competition coordinator;
 - members of the expert committee of the Competition;
 - representatives of organizations partners of the Competition,
 - Secretary of the Competition.
 - 8.4. Scientific director of the Competition:
 - prepares the draft Regulations on the Competition, amendments and additions to it;
 - is the chairman (co-chairman) of the expert commission of the Competition;
 - selects the composition of the expert commission of the Competition.
 - 8.5. Competition Coordinator:
 - ensures the invitation of members of the Expert Commission of the Competition;
- organizes the distribution of information letters to educational, research and scientific organizations of the Russian Federation and Eurasian countries;
- organizes registration (through the registration system of the EEYF website) and verification of compliance of received competition documents with established requirements, sends competition works to members of the expert commission for evaluation;
 - organizes and monitors the progress of the Competition;

- organizes the work of the expert commission during the international finals of the Competition;
- organizes the registration of diplomas, certificates and awarding of the winners and prize-winners of the Competition;
- organizes the collection of abstracts of competitive works of the Competition finalists and their transfer to the USUE Publishing House for inclusion in the collection of EEYF materials;
- organizes the collection of necessary documents for issuing cash prizes to the winners and prize-winners of the Competition;
 - draws up a report on the Competition.
- 8.6. An expert commission of the Competition is created to conduct an expert assessment of competitive works.

The Chairman of the Expert Commission of the Competition is the Director of the EEYF Congress, where the Competition is taking place. The co-chairman of the Expert Committee of the Competition is the scientific director of the Competition. The expert commission includes highly qualified pedagogical and scientific workers, leading specialists from among the organizers of the EEYF, as well as invited experts. More than half of the members of the expert commission must be representatives of third-party organizations. Decisions of the expert commission are made by open voting, a simple majority of votes of the members of the expert commission present, minutes are recorded, the minutes are signed by the chairman, secretary and members of the expert commission (Appendices 2, 3).

Information about the composition of the organizing committee and expert commission of the Competition is published annually on the Competition page of the EEYF website.

9. Management of the Competition at foreign/regional sites of the EEYF

- 9.1. The Competition is managed by the organizing committee of the foreign/regional EEYF site and the Competition coordinator of the EEYF site.
 - 9.2. Coordinator of the EEYF Competition:
- organizes the distribution of information letters to educational, research and scientific organizations in their country/region of Russia;
- organizes registration (through the registration system of the EEYF website) and verification of compliance of received applications with established requirements;
- organizes participants who applied to participate in the Competition through a foreign/regional platform to timely complete the final stage of the Competition remotely;
- sends information letters to the winners of the site, who took 1st to 3rd place among the site participants, about participation in the award procedure, which will take place on the territory of the site's head university on April 25, 2024.
