1. General regulations

- 1.1. These Regulations on the Competition of Initiatives "Youth Prospects" (hereinafter referred to as the Regulations) govern the procedure for organizing and holding the Competition of Initiatives "Youth Prospects" (hereinafter referred to as the Competition).
- 1.2. The Competition is held within the framework of the Congress of Schoolchildren of the Eurasian Economic Youth Forum (hereinafter referred to as the EEYF) and the EEYF site the Ural State University of Economics (hereinafter referred to as the USUE site).
 - 1.3. The Internet address of the EEYF website is www.eurasia-forum.ru
 - 1.4. Competition Organizer:

Federal State Budgetary Educational Institution of Higher Education "Ural State University of Economics" (USUE), Department of Admissions and Pre-University Training and the Department of Competition Law and Antimonopoly Regulation.

- 1.5. Competition Partners:
- Office of the Federal Antimonopoly Service for the Sverdlovsk Region;
- Office of the Federal Treasury for the Sverdlovsk Region;
- Ural branch of the Free Economic Society of Russia.
- 1.6 The purpose of the Competition is to develop the ability to analyze and define a problem, offer reasonable solutions based on one's own experience and acquired knowledge, formulate conclusions based on one's own view of the development of the situation.
 - 1.7. Competition Objectives:
 - formation of stable skills of rational thinking,
 - projection of rational thinking onto behavior and activity in life situations;
 - development of analytical abilities in participants;
- ability to predict multiple options for the development of situations with existing opportunities and find optimal solutions to get out of them.

2. Conditions of participation in the Competition, registration of participants

- 2.1 Students of grades 9-11 of educational institutions of Russia and foreign countries (hereinafter referred to as Participants) are invited to participate in the Competition.
- 2.2. Individual participation in the qualifying round and group participation in the in-person final are allowed in the Competition.
- 2.2.1. Applications for participation in the Competition are submitted before **March 21, 2025** through the registration form on the website (Appendix 1).

Participants of the Competition, representatives of foreign educational institutions, when registering first select the USUE site, and then the name of the Competition.

2.3. There is no registration fee for participation in the Competition. The costs of accommodation for out-of-town participants, meals and transportation costs for participation in the inperson stage of the Competition are paid by the participants themselves or by the sending organizations.

3. Stages and dates of the Competition

3.1. The Competition is an annual event. The specific dates for the Competition, as well as its main stages, are established by the order of the Rector of the Federal State Budgetary Educational Institution of Higher Education "Ural State University of Economics" (USUE).

The Competition is held in three stages.

3.2. 1. The first stage is the registration of participants (until March 21, 2025 inclusive) and verification of compliance with the requirements for Competition participants (Section 2 of these Regulations).

The first stage is held by the Competition Organizing Committee within the timeframe established by the Directorate of the Eurasian Economic Youth Forum and published on the EEYF website.

After registration on the EEYF website, the participant is sent a login and password to the email address they specified to access the specialized resource of the Competition, as well as instructions on how to work with tasks.

3.2.2. The second stage is (qualifying round). It is held remotely in the form of solving cases and writing detailed answers on a specialized resource of the Competition from March 22 to March 31, 2025.

Time to complete the task is 90 minutes. Number of cases - 1. Number of attempts to pass - 1.

The examination of the completed tasks on the specialized resource of the Competition is carried out by the expert commission of the Competition. The commission selects in absentia **from 15 to 20** finalists. The lists of finalists who have reached the final are published on the official portal of the forum in the section www.eurasia-forum.ru "Congress of schoolchildren".

3.3. The third stage - (final round) is held in person at USUE **on April 21, 2025**. Teams of 2-3 people are formed from the finalists of the qualifying round, by drawing lots among the participants present. As a result, the winning teams and prize-winning teams of the Competition are determined.

Participation in the final of the Competition will be held in person at the USUE site.

4. Procedure for holding the final and evaluation criteria

- 4.1. The third (final) round of the Competition includes:
- 4.1.1. Solving a socio-economic case and developing a strategy for resolving the proposed problem situation.

The correctness of the choice of legal acts for resolving the case, the level of analysis of the experience of current law enforcement practice, international experience in solving similar problems, the validity of the conclusions made, and the creativity of the approach are assessed. The maximum number of points is 25.

4.1.2. Public presentation-defense of the submitted proposals.

The quality of the presentation, the level of speech preparation, compliance with the style of the presentation, the correctness of the speech, argumentation, validity and timeliness of the answers to the questions of the commission are assessed. The maximum number of points is 25.

4.2. Based on the total number of points, the expert commission determines the winning team and prize-winners of the Competition.

4.3. If the number of points scored by the participants of the Competition is equal, the decision to recognize the winner and prize-winners of the Competition is made at the discretion of the expert commission.

5. Awarding of the winners

5.1. Based on the results of the final round, the competition committee awards 1st, 2nd and 3rd places.

Participants in the final stage of the competition are awarded participant certificates during the final defenses.

Participants who do not make it to the finals receive certificates in electronic form to the email addresses specified in the participants' applications. The mailing is carried out after all final events of the EEYF no later than May 30, 2025.

- 5.2 The expert committee has the right to allocate special nominations for each direction of the competition.
 - 5.3. The awarding of the finalists of the Competition will take place on April 21, 2025 at 17.00.
 - 5.4 Participants-students of the 11th grade receive certificates of laureates of the XV EEYF
- 5.5 Award documents of participants are taken into account when calculating additional points upon admission to USUE.

6. Competition Management

- 6.1. The Competition is managed by the EEYF Directorate and the Competition Organizing Committee.
- 6.2. To organize and conduct the Competition, an Organizing Committee is formed, approved by the order of the rector of USUE. The Organizing Committee includes:
 - Chairman of the EEYF;
 - Co-chairman of the EEYF;

Members of the Organizing Committee:

- Scientific Director of the Competition;
- Coordinator(s) of the Competition;
- Chairman and members of the expert commission of the Competition;
- Representatives of partner organizations of the Competition;
- Secretary of the Competition.
- 6.3. The organizing committee carries out general management of the organization and conduct of the competition.
 - 6.3.1. Chairman of the Organizing Committee:
- approves the Regulation on the competition, signs the order on the holding of the competition and the composition of the organizing committee of the competition, the order on the composition of the expert commission;
- Carries out general management of the organization and conduct of EEFM measures, in which the competition is held.
 - 6.3.2. Co -chairman of the organizing committee:
- Carries out direct management of the organization and conduct of the EEFM, together with the supervisor of the competition, forms the composition of the expert commission of the competition.

6.3.3. To conduct an expert assessment of the teams, an expert commission is created.

The chairman of the expert commission of the competition is the director of the EEYF Congress, in which the competition takes place. The expert commission includes highly qualified representatives of the scientific and business community; Russian and foreign experts in the field of jurisprudence, economics, expert activities and business analysis from higher educational institutions of the Russian Federation, countries of near and far abroad, academic science, business practitioners.

All decisions of the expert commissions are protocolized and signed by the chairman (co -chair), the secretary and members of the expert commission.

- 6.3.4. Scientific adviser to the competition:
- prepares a draft Regulation on the competition and provides it for approval to the rector, prepares changes and additions to him;
 - is the co -chair of the expert commission of the competition;
 - selects the composition of the expert commission of the competition;
- approves the chairman of the expert commission for assignments for the participants of the competition.
 - 6.3.5. Coordinator (s) of the competition:
 - provides an invitation to members of the expert commission of the competition;
- organizes the newsletter of information letters to educational, research and scientific organizations of the Russian Federation and foreign countries;
 - ensures the work of a specialized resource for the qualifying round of the competition;
 - organizes the final and the work of the expert commission during the final of the competition;
- organizes the registration of diplomas and awarding the winners and winners of the competition;
 - draws up a report on the competition.
- 6.4. Information on the composition of the organizing committee and the expert commission of the competition is annually published on the page of the EEYF website competition.
