## **1. General regulations**

1.1. These Regulations on the Competition of Initiatives "Youth Prospects" (hereinafter referred to as the Regulations) govern the procedure for organizing and holding the Competition of Initiatives "Youth Prospects" (hereinafter referred to as the Competition).

1.2. The Competition is held within the framework of the Congress of Management and Law of the Eurasian Economic Youth Forum (hereinafter referred to as the EEYF) and is implemented at the main site of the EEYF - at the Ural State University of Economics (hereinafter referred to as the USUE site), as well as at foreign/regional sites that have chosen this Competition.

The list of foreign and regional sites that have chosen this Competition is indicated on the Competition page of the EEYF website, as well as on the pages of the foreign/regional sites themselves on the EEYF website.

1.3. The Internet address of the EEYF website is [www.eurasia-forum.ru](http://www.eurasia-forum.ru)

1.4. Competition Organizer:

Ural State University of Economics (USUE), Department of Competition Law and Antimonopoly Regulation.

1.5. Competition Co-Organizers:

Universities-organizers of foreign and regional EEFM sites that have chosen this competition for implementation at their sites.

1.6. Competition Partners:

- Office of the Federal Antimonopoly Service for the Sverdlovsk Region;
- Office of the Federal Treasury for the Sverdlovsk Region;
- Ural Branch of the Free Economic Society of Russia.

1.7. The purpose of the Competition is to develop the ability to analyze and identify a problem, offer reasonable solutions, relying on one's own experience and acquired knowledge, and formulate conclusions based on one's own view of the development of the situation.

1.8. Competition Objectives:

- formation of sustainable skills of rational thinking,
- projection of rational thinking onto behavior and activities in life situations;
- development of analytical skills in participants;
- ability to predict multiple scenarios of situations with available opportunities and find optimal solutions to get out of them.

## **2. Conditions of participation in the Competition, registration of participants**

2.1. Bachelor's, specialist's and master's students of Russian and foreign universities, as well as employees of interested organizations under 35 years of age (hereinafter referred to as Participants) are invited to participate in the Competition.

2.2. Individual participation in the qualifying round and group participation in the in-person final are allowed in the Competition.

2.2.1. Applications for participation in the Competition are submitted before **March 21, 2025** through the registration system of the website (Appendix 1).

2.2.2. Competition participants, representatives of foreign/regional sites, first select their site when registering, and then the name of the Competition.



2.3. There is no registration fee for participation in the Competition. Accommodation expenses for out-of-town participants, meals and transportation costs for participation in the in-person stage of the Competition are paid by the participants themselves or by the sending organizations. The exception is the winners of foreign/regional venues of the Competition.

### **3. Stages and dates of the Competition**

3.1. The Competition is an annual event. The specific dates of the Competition, as well as its main stages, are established by the order of the Rector of the Federal State Budgetary Educational Institution of Higher Education "Ural State University of Economics" (USUE).

3.2. The Competition is held in three stages.

3.2.1. **The first stage is the registration of participants (until March 21, 2025 inclusive)** and checking for compliance with the requirements for Competition participants (Section 2 of these Regulations).

The first stage is held by the Competition Organizing Committee within the timeframe established by the Directorate of the Eurasian Economic Youth Forum and published on the EEYF website.

After registration on the EEYF website, the participant is sent a login and password to the email address they provided to access the specialized resource of the Competition, as well as instructions on how to work with the tasks.

3.2.2. **The second stage is (qualifying round)**. Conducted remotely in the form of solving cases and writing detailed answers on a specialized Competition resource **from March 22 to March 31, 2025**.

Time to complete the task - 90 minutes. Number of cases - 1. Number of attempts to complete - 1.

#### **- Conducting a qualifying round at the USUE site**

Examination of completed tasks on a specialized Competition resource. Conducted by the expert committee of the Competition at the USUE site. The committee selects in absentia from 15 to 20 finalists. The final number of finalists from the USUE site depends on the actual number of finalists from foreign/regional Competition sites. Lists of finalists who have reached the final of the Competition are published on the Competition page of the Congress of Management and Law of the EEYF.

#### **- Conducting qualifying stages at foreign/regional Competition sites**

Examination of completed tasks on a specialized Competition resource. The examination is carried out by expert commissions of foreign/regional Competition venues jointly with the expert commission of the USUE venue. Expert commissions select participants who took 1st, 2nd and 3rd place in the national/regional round of the Competition. The lists of the winner and prize-winners are published on the pages of the corresponding Competition venues of the EEFM website.

**The participant who took 1st place** in the qualifying round of the Competition is given the opportunity to participate **in the international final** of the Competition **in person**



**(April 21, 2025).** Travel and accommodation costs for the winner of the qualifying round are provided by the main organizer of the EEYF - USUE.

The participants who took 2nd and 3rd place will be ceremoniously presented with certificates and memorable gifts at the foreign/regional venue **on April 21, 2025**.

The general list of finalists of the international final of the Competition is formed from the finalists from the USUE site and the winners of foreign/regional sites that have chosen this Competition. The general list of finalists of the Competition is published on the EEFM website, on the page of the Competition of the Congress of Management and Law.

**3.3. The third stage - (final round).** Held in person at USUE **on April 21, 2025**. Work in the final takes place in teams of 2 or 3 people, which are formed by drawing lots among the participants present. As a result of the work, the winning teams and prize-winning teams of the Competition are determined.

Participation in the final of the Competition is held in person at the USUE site.

#### **4. Procedure for holding the final and evaluation criteria**

4.1. The third (final) round of the Competition includes:

4.1.1. Solving a socio-economic case and developing a strategy for resolving the proposed problem situation.

The correctness of the choice of legal acts for resolving the case, the level of analysis of the experience of current law enforcement practice, international experience in solving similar problems, the validity of the conclusions made, and the creativity of the approach are assessed. The maximum number of points is 25.

4.1.2. Public speech-defense of the submitted proposals.

The quality of the speech, the level of speech preparation, compliance with the style of the speech, the correctness of the speech, argumentation, validity and timeliness of responses to the questions of the commission are assessed. The maximum number of points is 25.

4.2. Based on the total points, the expert commission determines the winning team and the prize-winners of the Competition.


4.3. If the number of points scored by the participants of the Competition is equal, the decision to recognize the winner and prize-winners of the Competition is made at the discretion of the expert commission.

#### **5. Awarding of the winners**

5.1. Based on the results of the final round, the winner and prize winners of the Competition are determined. They are awarded with Diplomas of the 1st, 2nd, 3rd degree and the "Star of EurAsia" orders for 1st, 2nd and 3rd place, respectively.

All participants of the final round receive certificates of the Competition finalists in electronic form.

5.2. The winners and prize winners (1st, 2nd and 3rd place) of the Competition are awarded cash prizes within the framework of the Competition prize fund, established on the

basis of the order of the rector of USUE and in accordance with the protocol of the Competition expert commission.

Cash prizes (including income tax) are transferred by the Competition organizer within 1.5 months to the personal accounts of the winners and prize winners using the details provided to the Competition coordinator, subject to the following documents being submitted to the competition organizer:

- a printout from the personal bank account: bank details and personal account number for transferring money;
- a copy of the passport, pages 1, 2 and the page with registration;
- a copy of the TIN or a printout of the TIN data from the website.

The amount of the cash prize is published on the Competition page of the EEYF website and is divided equally between all team members.

5.3. Cash prizes for foreign participants participating in the final in person are issued at the USUE cash desk on the day of the awards ceremony.

5.4. Participants who take 1st, 2nd and 3rd place at the foreign/regional site will be awarded with certificates for 1st, 2nd and 3rd place in the national/regional round and small orders "Star of EurAsia". 5.5. The awarding of all finalists of the Competition will take place within the framework of the final events of the XV EEYF on April 24, 2025 simultaneously at the USUE site and at the foreign/regional sites of the Competition via online communication.

## 6. Competition Management

6.1. The Competition is managed by the EEYF Directorate and the Competition Organizing Committee.

6.2. An Organizing Committee approved by the order of the Rector of USUE is formed to organize and conduct the Competition. The Organizing Committee shall include:

- Chairman of the EEYF;
  - Co-Chairman of the EEYF;
- Members of the Organizing Committee:
- Scientific Director of the Competition;
  - Coordinator(s) of the Competition;
  - Chairman and members of the Competition expert committee;
  - Representatives of the Competition partner organizations,
  - Secretary of the Competition.

6.3. The Organizing Committee shall exercise general management of the organization and conduct of the Competition.

6.3.1. The Chairman of the Organizing Committee:

- Approves the Competition Regulations, signs the order on holding the Competition and the composition of the Competition organizing committee, the order on the composition of the expert committee;

- carries out general management of the organization and holding of the EEYF events, within the framework of which the Competition is held.

6.3.2. Co-chairman of the organizing committee:



– carries out direct management of the organization and holding of the EEYF, together with the scientific director of the Competition, forms the composition of the expert commission of the Competition.

6.3.3. An expert commission is created to conduct an expert evaluation of the teams.

The chairman of the expert commission of the Competition is the director of the EEYF Congress, where the Competition is held. The expert commission includes highly qualified representatives of the scientific and business community; Russian and foreign experts in the field of jurisprudence, economics, expert activity and business analysis from higher educational institutions of the Russian Federation, countries of the near and far abroad, academic science, business practitioners. More than half of the members of the expert commission must be representatives of third-party organizations.

All decisions of the expert commissions are recorded and signed by the chairman (co-chairman), secretary and members of the expert commission (Appendix 2, 3, 4).

6.3.4. The Academic Supervisor of the Competition:

- prepares the draft Regulations on the Competition and submits it to the rector for approval, prepares amendments and additions to it;
- is the co-chairman of the expert commission of the Competition;
- selects the composition of the expert commission of the Competition;
- approves the assignments for the participants of the Competition with the chairman of the expert commission.

6.3.5. The Coordinator(s) of the Competition:

- ensures the invitation of members of the expert commission of the Competition;
- organizes the distribution of information letters to educational, research and scientific organizations of the Russian Federation and foreign countries;
- ensures the operation of a specialized resource for holding the selection round of the Competition;
- organizes the final and the work of the expert commission during the final of the Competition; – organizes the issuance of diplomas and awarding of the winners and prize winners of the Competition;
- prepares a report on the Competition.

6.4. Information on the composition of the organizing committee and the expert commission of the Competition is published annually on the Competition page of the EEYF website.


