1. General regulations

1.1. These Regulations (hereinafter referred to as the Regulations) govern the procedure for organizing and holding the International Competition of Students of Secondary Vocational Educational Organizations "My Profession. Step into the Future" (hereinafter referred to as the Competition).

1.2. The competition is held within the framework of the Congress of Strategists of the Eurasian Economic Youth Forum (hereinafter EEYF). The Internet address of the EEYF website is www.eurasia-forum.ru

1.3. Competition organizer:

Federal State Budgetary Educational Institution of Higher Education "Ural State University of Economics" (USUE), USUE College.

1.4. The purpose of the competition is to develop educational motivation, cognitive interest in the future profession, popularize secondary vocational education specialties, and ensure research and project activities.

1.5. The main objectives of the competition:

- to form the basis for the student's understanding of the essence and social significance of his future profession, to demonstrate a sustainable interest in it;
- to develop skills of independent preparation, techniques and presentations;
- to identify the most gifted and talented students and to assist them in their professional orientation and continuing education;
- to promote the professional self-determination of students;
- to increase the prestige of educational institutions of secondary vocational education;
- to develop cooperation with educational organizations;
- to plan and implement one's own professional and personal development;
- to strengthen cooperation with social partners.

2. Conditions of participation in the competition, registration of participants

2.1. Students studying in secondary vocational education programs are invited to participate in the competition.

2.2. Participation in the competition is individual.

2.3. Applications for participation in the competition and abstracts of competition works are accepted through the registration system of the EEYF website www.eurasia-forum.ru. (Annexes 1, 2, 3).

2.4. Applications for participation in the competition must be submitted **until March 20, 2025**, or another deadline specified on the competition page of the EEYF website.

2.5. There is no registration fee for participation in the competition. Accommodation costs for out-of-town participants, food and transportation costs for participation in the in-person stage of the competition are paid by the participants themselves or by the sending organizations.

3. Этапы и сроки проведения конкурса

3.1. The competition is an annual event and is held during the summer semester. The final dates for the Competition, as well as its main stages, are established by the order of the chairman of the organizing committee of the EEYF, the rector of USUE and are published on the Competition pages of the EEYF website.

3.2. The competition is held in three stages.

3.2.1. The first stage (up to and including March 20, 2025) – registration of participants and verification of compliance with the requirements for participants of the Competition (Section 2 of these Regulations).

When registering, the participant attaches an abstract of his/her project as a separate file to the registration application form. The abstract reflects brief information about the competition project and should not exceed 1 page. The structure of the abstract, requirements for the abstract and a sample of its design are specified in Annexes 2 and 3.

3.2.2. The second stage (qualifying) (from March 21 to April 1, 2025) - examination of abstracts of competition projects, held in absentia. Based on the results of the qualifying round, 20 (twenty) finalists who have scored the highest number of points are determined.

The lists of finalists are published on the competition page and information letters about reaching the finals are sent to the finalist participants. If a finalist for any reason cannot take part in the finals in person, by decision of the organizing committee of the competition, he/she is replaced by the participant who took 21st place.

3.2.3. The third stage (final) (April 23-24, 2025) – held in person at USUE. The third stage includes the defense of competition projects prepared in the form of:

- 1) "Essay" - no more than 3 pages (Annex 4);
- 2) "Infographics" - no more than 5 slides (Annex 5);
- 3) "Presentation" - no more than 12 slides (Annex 6);
- 4) "Video" - no more than 3 minutes (Annex 7).

The finalist must cover the following sections of the project:

- 1) "Where it all began": the history of the emergence of the specialty, profession.
- 2) "Here and now": the development of the specialty today, social partnership.
- 3) "Let's look into the future": the prospects for the development of the profession.

The competition project on the topic "My Profession. Step into the Future" should reflect the implementation of tasks that correspond to the Federal State Educational Standard of Secondary Vocational Education in terms of general competencies:

- choose ways to solve problems of professional activity in relation to various contexts;
- use modern means of searching, analyzing and interpreting information and information technologies to perform tasks of professional activity;
- plan and implement their own professional and personal development, entrepreneurial activity in the professional sphere, use knowledge of legal and financial literacy in various life situations;
- carry out oral and written communication in the state language of the Russian Federation, taking into account the peculiarities of the social and cultural context.

Based on the results of the final round, the winner and prize-winners of the competition are determined.

4. Criteria for evaluating competition entries

4.1. Criteria for evaluating abstracts of competition works at the second (selection) stage (Annex 3):

- compliance with the competition topic, project sections (from 0 to 5 points);
- compliance with abstract formatting requirements (from 0 to 5 points);
- keywords (from 10 words) - (from 0 to 5 points);
- disclosure of the goals, objectives and results of the project (from 0 to 5 points).

Total abstract evaluation – up to 20 points.

4.2. Criteria for evaluating works during the third (final) stage:

- 1) "Essay": maximum points - 20 (Annex 4):

- Compliance with the competition topic, competition sections - from 0 to 5 points;
- Argumentation and logic of presentation - from 0 to 5 points;
- Originality - from 0 to 5 points;
- Literacy and design of work - from 0 to 5 points.

2) "Infographics": maximum number of points - 20 (Annex 5):

- Compliance with the competition theme, competition sections and disclosure of the topic - from 0 to 5 points;
- Originality of the idea and content and creativity of the work - from 0 to 5 points;
- Accessibility of understanding for the general public - from 0 to 5 points;
- Aesthetics of the work and design (combination of colors, fonts, graphic elements) from 0 to 5 points.

3) "Presentation": maximum points - 20 (Annex 6):

- Compliance with the competition theme, competition sections - from 0 to 5 points;
- Compliance with the goals and objectives of the competition, logic and transitions during the project - presentation from 0 to 5 points;
- Graphic illustrations, diagrams and graphs, animation for the presentation - from 0 to 5 points;
- Presentation design - from 0 to 5 points.

4) "Video": maximum points - 20 (Annex 7)

- Compliance of the work with the stated topic, information content - from 0 to 5 points;
- Argumentation and depth of topic disclosure, clarity of presentation - from 0 to 5 points;
- Creativity of the video (novelty of the idea, originality, flexibility of thinking) - from 0 to 5 points;
- Quality of photos, video shooting and aesthetics of the work - from 0 to 5 points.

5. Competition Management

5.1. The competition is managed by the EEYF Directorate and the competition organizing committee.

5.2. To organize and conduct the competition, an Organizing Committee is formed, approved by the order of the rector of USUE. The Organizing Committee includes:

- Chairman of the Organizing Committee of the EEYF;
 - Co-Chairman of the Organizing Committee of the EEYF;
- Members of the Organizing Committee:
- Scientific Director of the competition;
 - Coordinator(s) of the competition;
 - Members of the Expert Commission of the competition;
 - Representatives of the organizations - partners of the competition;
 - Secretary of the competition.

5.3. The Organizing Committee shall exercise general management over the organization and holding of the competition.

5.3.1. The Chairman of the Organizing Committee:

- approves the Regulations on the competition, signs the order on holding the competition and the composition of the organizing committee of the competition, the order on the composition of the expert commission;

- exercises general management over the organization and holding of the events of the EEYF, within the framework of which the competition is held.

5.3.2. Co-chairman of the organizing committee:

– directly manages the organization and holding of the EEYF, together with the scientific director of the competition, forms the composition of the expert commission of the competition.

An expert commission is created to conduct an expert assessment of the teams.

The chairman of the expert commission of the competition is the director of the EEYF Congress where the competition is held. The expert commission includes highly qualified representatives of the scientific and business community; Russian and foreign experts in the field of finance from higher educational institutions of the Russian Federation, countries of the near and far abroad, academic science, audit companies; business practitioners.

More than half of the members of the expert commission must be representatives of third-party organizations.

5.3.3. The scientific supervisor of the competition:

- prepares the draft Regulations on the competition and submits it to the rector for approval, prepares amendments and additions to it;
- is the co-chair of the expert committee of the competition;
- selects the composition of the expert committee of the competition;
- develops and approves with the chairman of the expert committee assignments for the participants of the competition.

5.3.4. Competition coordinator(s):

- ensures the invitation of members of the competition expert committee;
- organizes the distribution of information letters to educational, research and scientific organizations of the Russian Federation and foreign countries;
- ensures the operation of a specialized website for the selection round of the competition;
- organizes the final and the work of the expert committee during the final of the competition;
- organizes the registration of diplomas and the awarding of winners and prize winners of the competition;
- prepares a report on the competition.

5.3.5. To conduct an expert evaluation of the competition works, an expert committee of the Competition is created.

The chairman of the expert committee of the Competition is the director of the EEYF Congress, where the Competition is held. The co-chairman of the expert committee of the Competition is the scientific director of the Competition. The expert committee includes highly qualified representatives of the scientific and business community; Russian and foreign experts in the field of finance from higher educational institutions of the Russian Federation, countries of the near and far abroad, academic science, audit companies; business practitioners. More than half of the members of the expert committee must be representatives of third-party organizations.

The decisions of the expert committee are made by open voting, by a simple majority of votes of the members of the expert committee present, are recorded, the minutes are signed by the chairman, secretary and members of the expert committee (Annexes 8, 9).

The expert committee has the right to appoint additional nominations in the competition.

5.4. Information about the scientific supervisor, coordinator(s), and members of the expert committee of the competition is published annually on the competition page of the EEYF website.

6. Awarding of the winners

6.1. Based on the results of the final round, the winner and prize winners of the competition are determined. The winner and prize winners are awarded with Diplomas of the 1st, 2nd, 3rd degree and orders for 1st, 2nd, and 3rd place, respectively.

All participants of the final round receive certificates of competition finalists.

6.2. Participants who take 4th and 5th places, as well as winners of additional nominations of the competition (if there are nominations) are awarded certificates for 4th and 5th place in the competition, or for winning a nomination.
